### **GENERAL FUND SCHOLARSHIP**

Established: circa 1960

Background: The General Fund (GF) Scholarship is from fundraisers or annual donations or pledges from businesses, organization, individuals and general memorials that have no specific criteria attached to the donation. The Scholarship Committee distributes these funds using a rubric of awarding points for the below criteria.

Amount: ~ \$15,000 (split among applicants based upon points)

Key Criteria: Grades, commitment to educational goals, community service, school and community involvement, financial need and presentation of self.

### **NANCY QUINN 4-YEAR MEMORIAL SCHOLARSHIP**
